<b>WHAT WILL I DO?</b>	You work with the pharmacist in a patient- or customer-focused setting to perform clerical duties and manual tasks in preparing medications. You'll track inventory, make and take orders and interact with customers and patients.	You assist in production of chemical compounds and pharmaceutical products. You will also likely provide research findings on new and existing technologies and procedures. This is advanced manufacturing at the scientific level, so get your clean suit on.	You are responsible for collecting, monitoring, processing and distributing adverse event reports and information requests for the company. You research and review safety and medical information for assigned products.	You have a variety of roles around the selling process, from developing relationships to making calls on physicians and practices. You must be able to understand and communicate very complex subjects to an audience that doesn't have a lot of time and knows a lot more than they let on.	You assist in dosage packaging development projects, including package design, tooling design and construction, testing and filing the paperwork.	You are the marketing person for STEM. You can speak the language, you understand the concepts, but you don't need to be a science or math whiz. You need to be able to communicate effectively. This is both a project management role and a strategic communications role.	You work in a lab performing all kinds of biochemical, biological and immunological tests, documenting results and helping the organization move treatments to market.	You live on the business side of the equation. This is analytics—but about how the product will sell, how it will perform financially and how well it will be adopted in the market place.	You don't necessarily do the scientific work—you set the strategy, define the tests and analyze the results.	Compounds and dispenses prescribed drugs in a healthcare facility environment. Also responsible for transferring prescriptions, handling incoming physician calls, logging data into the computer and Drug Utilization Review. Requires a bachelor's degree and/or an advanced degree in pharmacy.
